**SCHEDULES:** Enclosed, you will find your child's team assignment & schedule. **It is a ten game schedule with an 8 game guarantee; the first two cancelled games will not be rescheduled. Practices that are cancelled will not be rescheduled.**

**CANCELLATIONS:** In the case of severe weather, cancellations will be posted at 586-949-0400, press 4, then 1. This line is updated at 4:30PM. New this season, we have signed up with a mobile messaging service that will allow us to send a cancellation text message to your mobile phone (standard text messaging charges will apply.) **To sign-up for this type of notification, text the word BASKETBALL18 to 84483. **UNIFORMS:** Players receive a pair of shorts and a dri-fit T-shirt. These uniforms will be available from your coach the first week of January.

**PICTURE DAYS:** J. L. Photo will be our sports photographer and pictures will take place on Saturday, February, 3<sup>rd</sup> inside of the Chesterfield Township Municipal Offices. Picture appointment times will be available to view on our website at parks.chesterfieldtwp.org and picture packets will be available from your child's coach in mid-January. Our department will also email a link to all registered participants for advance purchasing online. This link will be available the week of January 26<sup>th</sup>. Pictures will be delivered to coaches for distribution before the season ends.

**LAST GAME:** Coaches will give an on-the-court presentation where each player will receive a participation certificate.

Sugarbush Elementary School located at 48400 Sugarbush (South of 23 Mile & North of Naldrett Elementary)

Youth Center located at 46000 Sugarbush (South of 21 Mile Road)

**SCHOOL POLICIES:** When using school facilities, the policies listed below must be followed by all players, spectators, and staff. Violation of these policies will jeopardize our ability to use the schools for further programming.
